Dear Habitat family,

Another year has rolled by and Greater Albuquerque Habitat for Humanity was again blessed by the generosity of all those who understand and embrace our mission to provide affordable housing and promote safety and stability for low-income families in our community.



We continued on our path, and purchased land in March of this year that will begin infrastructure work in the fall, and enable us to help 11 more families achieve homeownership. Finding affordable land and controlling building costs is always a challenge, but we remain positive and committed. One of Habitat's strategic goals is to continually fund the land account in order to sustain our mission. It is humbling to see our donors, sponsors, grantors, community partners, volunteers and staff embrace this need and continue to support our work. You are changing lives!

COVID-19 hit during the 4th quarter of our fiscal year and presented unprecedented challenges for all of us. The virus underscored the dire need for affordable housing not just in New Mexico, but throughout the entire country. **COVID-19 has been a stark reminder of how important it is to have a decent place to live where we can be safe and secure with our families.** Many businesses had to halt or greatly adjust operations. Habitat was no exception; but we were fortunate to continue operating with our reserves.

We will continue to bring the opportunity for homeownership to those we serve. Challenges are really how we innovate and grow.

ReStore had another record year with sales over \$1.1M in spite of being closed for two months. Our annual fundraising breakfast normally held in April had to make a quick turnabout when things were shut down, and for the first time our event went "online." It was quite an undertaking, but thanks to all of you, it was our best yet. But just like all of you, we missed seeing our friends in person and celebrating with our families. We hope that 2021 will be a lighter, brighter time and allow us all to gather again safely.

It has been my honor and privilege to lead this dynamic organization and work alongside the dedicated staff who make amazing things happen. I am confident that Habitat will continue to grow and thrive for decades to come. What matters most is that we hear the call to action and respond. Each homeowner commits to working 550 hours of sweat equity and taking financial education classes. Families learn to budget and save money before they take ownership of their Habitat home. Once they move in, homeowners assume a mortgage with a 0% interest loan. Your support is a handup for families – helping to break the cycle of poverty and transforming lives for generations to come.

In 2021, Yvette will become the homeowner of the Honor and Remember House, dedicated to Veterans.


